She also volunteers at the many legal fairs held by the Second Judicial Pro Bono Committee, and she bakes amazing cakes, which she generously shares with the staff at the Second Judicial District Court. CIMIL LEGAL SERVICES

Providing legal help to those who need it most ensures that equal justice under the law is a right, not a privilege. This month, we spotlight New Mexico Legal Aid (NMLA), a 501(c)(3) nonprofit law firm dedicated to serving low-income clients and groups throughout New Mexico.

With ten offices spread across the state, NMLA has been a pillar of support since its establishment in 2003, following the merger of the New Mexico Legal Aid Society of Albuquerque with other civil legal aid providers across the state.

NMLA's mission is deeply rooted in the belief that every individual deserves equal access to justice, regardless of their socioeconomic status. In a state where nearly half a million residents live below the poverty line, NMLA serves as a lifeline for those facing significant legal challenges.

The organization provides not only direct legal representation but also education, resources, and legal clinics across the state. NMLA was instrumental in creating the New Mexico Landlord Tenant Guide, striving to promote family and economic stability.

NMLA's services cater to individuals at or below 125% of the federal poverty guidelines, ensuring they have access to benefits and can protect their rights. Their comprehensive support spans various areas of law.

By dedicating herself to Mediation Mondays, Michelle assists participants in engaging in a process that may result in a negotiated settlement. A byproduct of such a resolution is that some of the pressure on the family court dockets can be alleviated.

Michelle has found that mediation can lead to better results as it encourages communication and cooperation and can lead to creative solutions where the participants can have greater control in the very personal arena of ending a marriage or resolving the sharing of custody. Their four primary practice groups are Housing Law, Interpersonal Violence and Family Law, Consumer Law, and Economic Security. They also offer specialized services for the LGBTQ+ community, veterans, Native Americans, low-income taxpayers, migrant farmworkers, and disaster victims. These services reflect NMLA's commitment to ensuring that justice is accessible to all, particularly to New Mexico's most vulnerable populations. Additionally, NMLA is home to the Volunteer Attorney Program (VAP), which increases access to justice by connecting low-income New Mexicans with pro bono attorneys for direct representation and brief advice through legal clinics and fairs.

NMLA's dedication to equal justice is evidenced by its wide range of services, which are aimed at helping New Mexico's most vulnerable populations. By ensuring that legal representation and resources are accessible to all, NMLA upholds the principle that justice should be a fundamental right for everyone.

ATJ ACTIVITIES 2024 National Center for State Courts Legal Deserts Summit

New Mexico was able to send a team to the inaugural Legal Deserts Summit, presented by the National Center for State Courts and held in Nevada from May 20th through May 22nd. New Mexico was one of fourteen teams present, with eighty representatives in attendance.



Participants at the Summit were from the courts, state bar organizations, educational institutions, libraries, civil legal service providers, public defenders, and Access to Justice Commissions, with the National Center for State Courts organizing and providing experts to guide states in planning and refining their next steps. The Summit focused on the growing need nationwide to implement innovative solutions to increase access to justice resources with an emphasis on how states can collaboratively leverage resources and Access to Justice Commissions.

New Mexico's team included Justice Vargas, Justice Bacon, Judge O'Connell, Judge Mowrer, New Mexico State Bar President Erin Atkins, UNM Law Associate Dean, Professor Sherri Thomas, New Mexico Legal Aid Director Sonya Bellafant, and Access to Justice Program Director Twila Hoon (not pictured).



Topics included the utilization of GIS mapping, and the NCSC provided each state with a GIS resource map. Discussions included the benefits and parameters of justice workers and paraprofessionals, leveraging collaborative efforts via Access to Justice Commissions and alternative admissions to law practice. Justice Bacon also presented with Wyoming's representatives regarding attorney shortage incentive programs to engage future attorneys in rural areas.
